

# Joachim Herz Award 2025 – Guidelines



The "Joachim Herz Award" is awarded annually to outstanding up-and-coming scientists either in the natural sciences, engineering or in economics who have the potential to make an impact through excellent research that is both societally and practically relevant. The award aims to support them in deepening their interdisciplinary research and ideally promoting the transfer of their research results. In 2025 the award will be granted by the "New Materials and Resources of the Future" cluster; the first award was given in 2024 by the former "Economy" program area (in the future, it will be awarded by the "Entrepreneurship" cluster).

## 1 Target group

The award is aimed at early-career scientists with a doctorate. To be eligible, they must show outstanding potential in their field of research and their research must demonstrate interdisciplinary approaches to solving societal challenges. The target group includes individuals or research groups working at a university or other research institutions (public or private non-profit) in Germany. Researchers from other European countries who are not yet working at a research institution in Germany at the time of application are also eligible to apply, if they have taken up a position at a German research institution by the time of the award ceremony.

International research groups that are active across institutions may still apply for the "Joachim Herz Award". It will then be necessary to determine which institution (based in Germany) can best manage the funding of the joint research.

## 2 Call for applications

The award is granted annually, alternating between the clusters "Entrepreneurship" and "New Materials and Resources of the Future".

The Joachim Herz Foundation (Joachim Herz Stiftung, JHS) announces the call for applications for the "Joachim Herz Award" by sending emails to relevant institutions, via its social media channels, its website and by other means.

The application and selection process is carried out by the JHS.

## 3 Application

Applications for the award can be made by application or nomination.

All application documents must be submitted digitally. Access to the application platform and deadlines for submission are published in the respective call for applications.

Applications submitted after the deadline will not be considered for selection.

#### **4 Selection of the awardee(s)**

The person or group with the most promising research proposal will be selected by an expert jury. The most important selection criteria are the recognizable potential for excellence of the applicant as well as an interdisciplinary and preferably application-oriented research approach of the project outline. The jury will be selected by the JHS and will be composed of renowned scientists and experts who have demonstrated excellence and expertise in the respective subject area of the call.

The awardee(s) will be selected in a two-step process:

Firstly, all applications are formally reviewed by the JHS. The jury then examines which applications appear fundamentally worthy of funding. These applications can either be reviewed by the jury members themselves or by external experts. External reviews may be requested in particular in case of partiality within the jury, if there is insufficient consensus or if the jury members wish to have an external assessment. On the basis of the evaluation, the jury will draw up a shortlist of applicants who will be invited to present their projects to the jury in a personal pitch.

At the request of the jury or the foundation, additional experts may be invited to attend the applicants' pitches. After the presentation, the jury meets to select the individual or group to receive the award based on the application documents, the pitches, and – if available – the external reviews. The formal decision is ultimately made by the JHS Management Board, taking into account the recommendations of the jury and experts.

Applicants are not entitled to a justification of the selection decision.

#### **5 Funding**

The funding amounts to up to EUR 500,000 and is granted for the realization of the project presented by the awardee in the application.

A usage guideline specifies the permissible the possible uses and requirements (e.g. eligible cost types) of the funding.

Within this framework, the awardees independently decide on the scientific use of the funding.

#### **6 Allocation of Funding**

The basis for awarding the funding is a grant agreement between the JHS, the institution (public or nonprofit) where the awardee holds a position, and the awardee. The funding will be allocated for a specific purpose to the institution where the awardee is employed. In the case of multiple awardees working in a group, the funding will be allocated to multiple institutions only in exceptional cases.

The funding is granted on the basis of an award letter. By accepting the award, the awardee or the co-recipient institution acknowledges the guidelines and modalities of use.

## **7 Duration**

The funding may be utilized within a period of three years. The term begins on the first day of the period for which funding is initially requested as part of the draw down plan, at the earliest on the calendar day following the date of the award ceremony, but not later than six months after it.

## **8 Award ceremony and accompanying conference**

The award will be presented to the awardees at an official ceremony. An accompanying conference, organized by the award winners, may be held at the same time or at a later date.

The costs of the award ceremony and conference will be covered by the JHS.

## **9 Miscellaneous**

The JHS reserves the right to revoke an award and claim a refund if the application is false or incomplete, if the conditions of approval are not met, or if there are other important reasons for revocation. There is no entitlement to funding from the JHS.

The JHS also reserves the right to change or amend these guidelines.
